Re: Change in respect of Templeton Global Smaller Companies Fund¹ (Code: TGC), Franklin Global Convertible Securities Fund² (Code: TGS), Franklin Technology Fund (Code: TTF), Templeton Asian Growth Fund (Code: TAG), Templeton Emerging Markets Fund (Code: TEM), Templeton Global Equity Income Fund (Code: TGI), Templeton Global Total Return Fund (Code: TTR) and Franklin U.S. Opportunities Fund (Code: FOF)(the "PRU-Investment Choices") available under the Policies (as defined below),

IMPORTANT: This notice contains important information and requires your immediate attention. The PRU-Investment Choices are available under PRUlink Empower Investment Plan, PRUlink portfolio investment plan, PRUlink single premium investment plan, PRUlink investment plan, PRUlink smart wealth builder, PRUkid extra (previously known as PRUkid edulink), PRUlink assurance (previously known as PRUlink Diamond, PRUlink Gold and PRUlink Silver), PRUlink assurance plus, PRUlink Investlife, PRUlink optimiser plus (previously known as PRUlink optimizer), PRUretirement extra (previously known as PRUretirement plus and PRUretirement plan), Investment Plus, PRUflexilife, PRUlink maxisavings, PRUlink Protector, and PRUlink wealth builder (collectively, the **"Policies"**).

We have been informed by Franklin Templeton Investments (Asia) Limited on the change of depositary and administrative agent of Franklin Templeton Investment Funds and its sub-funds including those which are the reference funds of the PRU-Investment Choices.

Currently, J.P. Morgan Bank Luxembourg S.A. ("JPMBL") is the depositary and administrative agent of the Franklin Templeton Investment Funds and its sub-funds. JPMBL and its affiliates are collectively referred to as "JPMorgan" in this letter.

As part of an internal restructuring with the aim to streamline JPMorgan's banking entity structure across Europe, three banking entities in the JPMorgan group domiciled respectively in Germany, Luxembourg and Ireland and their branches across the region will be merged into a single European bank ("Merger"). The date when the Merger takes legal effect will be the date on which the local court of Frankfurt registers the Merger in the commercial register (the "Effective Date"), which is expected to be on or around 22 January 2022.

JPMBL will be one of the impacted legal entities of the Merger and will be merged into J.P. Morgan Societas Europaea ("JPMSE") on the Effective Date. All of JPMBL's assets and liabilities will be transferred to the Luxembourg Branch of JPMSE, which will operate as J.P. Morgan SE – Luxembourg Branch ("JPMSE Luxembourg"). If there is any change in the Effective Date or any other material changes to the Merger, a notice shall be issued to investor of the Franklin Templeton Investment Funds and its sub-funds separately.

On the Effective Date and in accordance with Luxembourg laws, JPMBL will cease to exist and the depositary and fund administration function of JPMBL will transfer from JPMBL to JPMSE Luxembourg, and JPMSE Luxembourg will succeed JPMBL as the depositary and administrative agent of Franklin Templeton Investment Fund and its sub-funds. JPMSE Luxembourg will assume all rights and obligations that JPMBL currently has under its existing agreements with Franklin Templeton Investment Fund, and accordingly the rights and obligations of its sub-funds with respect to the depositary and administrative agent will not be impacted. The business operations of JPMBL will be carried on without interruption

by a locally fully passported, Luxembourg based branch of JPMSE (i.e. JPMSE Luxembourg) and all current reference to JPMBL in the Explanatory Memorandum of Franklin Templeton Investment Fund and the Product Key Facts Statements of its sub-funds ("KFS", collectively with the Explanatory Memorandum, "Offering Documents") will be replaced by JPMSE Luxembourg as of the Effective Date. There will be no changes to the scope of services provided to Franklin Templeton Investment Fund, and no change in the level of fees payable by Franklin Templeton Investment Fund and its sub-funds to the depositary and the administrative agent.

As a result, the PRU-Investment Choices will also experience the same change regarding the change of the reference fund on the same Effective Date.

Please note that the overall risk profile of the PRU-Investment Choices will not change as a result of the change of depositary and administrative agent described above.

All costs (including the legal and other administrative costs) associated with the changes to Franklin Templeton Investment Funds and its sub-funds above will be borne by JPMorgan.

As a holder of the units of the PRU-Investment Choices, if you do not wish to accept the changes, you may choose to switch your existing units of the PRU-Investment Choices and redirect your premium allocation / dividend allocation to other investment choice(s) by submitting a request to Prudential. You can arrange your request through our website www.prudential.com.hk at myPrudential or submit to Prudential the duly signed form available from your consultant or our Customer Service Center. Currently, you can opt for an unlimited number of switching of investment choices and change of premium allocations or dividend allocations for future contributions in Prudential investment-linked insurance plans without incurring switching charges. Or else, you are not required to take any action for the changes described.

保誠投資選項適用於雋賦投資計劃、「雋景」組合投資計劃、「雋景」整付保費投資計劃、「運籌」晉景投資計劃、「運籌智賞」投資計劃、俊傑尚盛計劃〔早前名稱為俊傑智選計劃〕、「運籌」智選保障計劃〔早前名稱為保誠運籌鑽石計劃、保誠運籌金計劃及保誠運籌銀計劃〕、「運籌」財智保障計劃、「投資創富」保障計劃、「運籌」優越投資計劃〔早前名稱為「運籌」盈豐投資計劃〕、尊尚退休寶計劃〔早前名稱為豐裕退休寶計劃及「退休寶」計劃〕、「投資寶」、「卓越人生」保障計劃、「極蓄」智選計劃、「運籌」萬全保障計劃及「運籌智富」投資計劃〔統稱「保單」〕。

我們接獲富蘭克林鄧普頓投資 (亞洲) 有限公司通知·富蘭克林鄧普頓投資基金及其子基金當中包括保誠投資選項之參考基金的存管人及行政代理之變更。

目前·J.P. Morgan Bank Luxembourg S.A. (「JPMBL」)為富蘭克林鄧普頓投資基金及其子基金的存管人及行政代理。 JPMBL 及其相關聯公司於本函件內統稱為「JPMorgan」。

作為旨在精簡 JPMorgan 橫跨歐洲的銀行實體架構之內部重組的一部分·JPMorgan 集團中分別在德國、盧森堡及愛爾蘭註冊的三個銀行實體及其在該地區的分行將合併為一間單一歐洲銀行 (「合併」)。合併生效之日期將為法蘭克福當地法院在商業登記處註冊合併之日期 (「生效日」).預期為 2022 年 1 月 22 日或前後。

JPMBL 將成為合併中其中一個受影響的法律實體及將於生效日併入 J.P. Morgan Societas Europaea (「JPMSE」)。 JPMBL 的所有資產及負債將轉移至 JPMSE 的盧森堡分行·該分行將作為 J.P. Morgan SE 的盧森堡分行 (「JPMSE 盧森堡分行」)運營。如生效日有任何變更或合併有任何其他重大變動·富蘭克林鄧普頓投資基金及其子基金的投資者將會收到另行通知。

於生效日·根據盧森堡法律·JPMBL 將不復存在·JPMBL 的存管及基金管理職能將從 JPMBL 轉移至 JPMSE 盧森堡分行,JPMSE 盧森堡分行將接替 JPMBL 作為富蘭克林鄧普頓投資基金及其子基金的存管人及行政代理。 JPMSE 盧森堡分行將承擔 JPMBL 現時根據其與富蘭克林鄧普頓投資基金的現有協議所擁有的所有權利和義務·因此其子基金有關存管人和行政代理的權利及義務不會受到影響。 JPMBL 的業務運營將由 JPMSE 擁有本地完全牌照通行權、位於盧森堡的分行(即 JPMSE 盧森堡分行)不間斷地進行·且自生效日期起·富蘭克林鄧普頓投資基金的基金說明書及其子基金的產品資料概要(「產品資料概要」,與基金說明書合稱「發售文件」)中所有現時有關 JPMBL 的提述將被 JPMSE 盧森堡分行取代。向富蘭克林鄧普頓投資基金提供的服務範圍不會發生變化,富蘭克林鄧普頓投資基金及其子基金應付給存管人和行政代理的費用水平不會發生變化。

因此、保誠投資選項將就參考基金的修訂於相同生效日期作出相同更新。

請注意,上述變動將不會導致保誠投資選項的整體風險類別有所改變。
